# Catalogue of the Sir Aurel Stein Papers in the British Museum Central Archives

The British Museum Central Archives contains two boxes of correspondence and papers relating to Sir Aurel Stein (1862–1943) and his expeditions to Chinese Central Asia and Persia, and the study, publication and division of the archaeological finds from these expeditions. The papers date from 15 February 1905 to 1 October 1948. This listing is designed to match the usual format for recording archives, and also to give a brief summary of the contents of the correspondence and papers.

In some cases, correspondence was addressed to an official position (e.g. Secretary of State for India) rather than to a named individual. Where the personal name is known, it has been listed. Where there is any ambiguity, the official position given in the document has been listed. There is some inconsistency of names, e.g. H.M. Legation, H.B.M. Legation and British Legation, and these are listed as they appear in the documents. There are a few abbreviations: BM = British Museum; V&A = Victoria & Albert Museum; H.M. = His Majesty; H.B.M. = His Britannic Majesty.

Kharoshthi and Chinese documents are to stay in London for study, decipherment and publication, and then to be sent to India. The Government of India recommends A.F.R. Continues Stein's account of his visit to Dunhuang and subsequent surveying work in the western and central Nanshan mountains. (6 pages)

Cover note, enclosing a letter from Stein [CE32/23/23/2]. Godley states that Lord Morley is not in a position to judge the force of Stein's complaints about the accommodation offered at the BM, and that the V&A cannot accommodate Stein in the galleries of the Oriental Museum in the Imperial Institute Road, as Stein suggests. **Stein (Natural History Museum) to Under-Secretary of State for India, 20 May 1909.**

Refers to Stein's meeting with T.W. Holderness on the accommodation offered to Stein at the BM. Stein has complained about the conditions, and Holderness inspected the accommodation on 3 May 1909. The Collection was originally delivered to the Natural History Museum, where Stein had started to unpack them. Having spoken with Cecil Smith (Director, V&A), in the hope that accommodation for the Collection might be found in the Indian Museum, Stein now suggests that more suitable accommodation might be found in the Cross Gallery at the V&A (Stein attaches a letter from Smith [17 May 1909]) or that he might be allowed to remain in the Natural History Museum. Requests instructions for the removal of the Stein Collection from the Natural History Museum to the BM in Bloomsbury. Requests that these instructions also be sent to F.H. Andrews as Stein will soon be on leave, and asks if the BM can provide any glass-covered cases. Handwritten note in pencil: 'D.P.L. [Director and Principal Librarian] wrote to Sir T.W.H. [T.W. Replies to Thompson's letter (3 July 1909) about the accommodation of the Stein Collection. Lord Morley acknowledges the BM's consideration in this matter and requests that Stein might be allowed to occupy the basement rooms for a period not exceeding 2½ years from the present date. As Stein is on six months' leave, instructions have been given to F.H. Andrews regarding the removal of the Collection from the Natural History Museum to the BM in Bloomsbury. Recommends that glass doors be fitted to the newspaper racks, also the purchase of at least 100 light handling trays, at a total cost of £120. (2 pages)

**Postscript**

The Stein Collection, displayed at the British Museum in 1914, was one of the first exhibitions displayed in the new Edward VII Galleries in the British Museum extension. The British Museum Central Archives holds a number of press cuttings relating to the opening of the extension, which have been listed below. There are also several volumes of archives relating to the extension; in particular, there is a collection of governance and administrative papers [British Museum Extension General Papers, 2 vols (vol. 1 covers 1894–1909; vol. 2 covers 1909–1914)]. The book *The Buildings of the British Museum, Illustrated from Prints and Drawings* was prepared by order of the Trustees on the occasion of the Opening of King Edward the Seventh's Galleries, May 1914 (London, 1914), in a limited edition of 101 copies. An exhibition catalogue was also published: *Guide to an Exhibition of Paintings, Manuscripts, and Other Archaeological Objects, collected by Sir Aurel Stein, K.C.I.E., in Chinese Turkestan*.
